

General terms and conditions

- Legal residence in Lux^.
- Have a right of residence
- Be registered with the RNPP (have a Luxembourg matricule)
- Reside where habitual residence is
- At least 25 years of age
- have an income, alone or with their domestic community, that does not exceed the thresholds (set by law)
- Be and remain registered with ADEM (looking for a job)
- Find out about all the possibilities for assistance in Lux. or abroad to improve your situation (find out if you are entitled to unemployment benefits, a pension, etc.).

Household community

- Persons living in a joint household/with a joint budget
- Cannot provide material proof that they live elsewhere
- These proofs are:
 - >Lease contract
 - >Rent receipts
 - >Title deeds to residential property
 - >bank/accounting documents proving payment of rent
 - >Documents proving payment of electricity, gas and council bills.

!!Proof must cover at least 6 months from the date of the REVIS request!!

No REVIS if:

- Having voluntarily stopped or reduced his work.
- Dismissed for gross misconduct
- Unemployment benefit withdrawn
- Non-compliance with collaboration agreement signed with ADEM/ONIS
- Unpaid leave/leave for part-time work in private or public sector
- Left Luxembourg for more than 35 days in a calendar year

For third-country nationals:

- BPI can request REVIS on a regular basis
- if you are neither BPI nor stateless, you must:
 - > have resided in Luxembourg for at least 5 years (continuous or not) in the last 20 years!!!BUT!!!
 - > have long-term status

REVIS - Revenu d'inclusion sociale

Different actors

- Fonds national de solidarité (FNS) = REVIS management (applications, decisions, payments, etc.)
- Office national d'inclusion sociale (ONIS) = intensive monitoring of beneficiaries and stabilization and/or activation measures
- Employment Development Agency (ADEM) = regular monitoring of beneficiaries and organization of employment measures

REVIS components

ALLOCATION D'INCLUSION

Financial assistance that provides a means of subsistence for people who have no income or whose income does not reach a certain threshold.

ALLOCATION D'ACTIVATION

Allowance for people taking part in REVIS activation measures

Exemptions

Registration at ADEM:

- Full-time employee
- Unable to work for physical or mental health reasons (based on medical opinion issued by FNS-appointed doctor)
- Reasoned opinion from ADEM regarding inability to enter the regular job market (based on personal situation, language skills and professional background)
- Recipient of an old-age or disability pension
- Over 65 years of age
- Recipient of cash sickness or maternity benefit
- Beneficiary of parental leave
- Caregiver of a person receiving long-term care insurance
- Completing conventional or general secondary education
- Self-employed with professional income below the unskilled SSM wage rate
- Self-employed with professional income equal to or greater than the unqualified SSM wage rate

No exemption for:

- Have a measure of preventive detention or custodial sentence!!! But!! can request the REVIS if:
 - > subject to the semi-liberty regime
 - > benefits from suspension of execution of sentence, parole or placement under electronic surveillance
 - Pursues higher education
 - Holder of a certificate of care

Age requirement (under 25)

- is raising a child for whom she receives child benefit
- Is at least 7 months pregnant (certificate stating due date)
- Is unable to earn a living within the legal limits due to illness or disability
- Home caregiver for a person receiving long-term care insurance

REVIS CALCULATION

- determined on the basis of the domestic community and its income
- applicant must declare to the FNS his total gross income and all his assets and those of his domestic community
- Some income must be declared
- Some income is not declarable

REVIS request

Different steps:

INTRODUCING THE REQUEST

1. Consolidated household information, signed by all adult members
2. Form for each adult member (to be added to the first part of the file)

=> Complete, sign and send by post

=> To be sent to the SNSF

=> Can be completed with your social worker or an SNSF staff member

ATTACHMENTS

- Copy of identity card for adult applicants
- Proof of legal residence in Lux. for a period of 5 (persons who are neither stateless nor BPI)
- Copy of MAEE international protection decision
- RIB (bank details) of main applicant

=> if anything is missing, the FNS will contact you.

DECISION

- Informed by registered letter
- 40-day appeal period
